**ORDER OF SUMMARY SUSPENSION FOR NONCOMPLIANCE WITH
MANDATORY IOLTA REPORTING REQUIREMENTS**

Pursuant to Tennessee Supreme Court Rule 43, Section 14, the license to practice law in this State of the following listed attorneys is summarily suspended for failing to timely submit certification that all eligible funds that are required pursuant to RPC 1.15(b) to be held in an IOLTA account are, in fact, so held and to provide the name(s) of the financial institution(s) and account number(s) where such funds are deposited.
